HIT Commons is a public/private partnership designed to accelerate and advance health information technology adoption and use across the state, leverage public and private investments, and expand access to high value data sources. HIT Commons is co-sponsored by the Oregon Health Leadership Council (OHLC) and the Oregon Health Authority (OHA), and is jointly funded by OHA, hospitals, and health plans.

OHLC CIE Early Adopter Efforts

OHLC supported interested stakeholders in engagement and contracting efforts with Unite Us. In late October, OHLC, Unite Us and partners announced "Connect Oregon" a CIE effort to connect 21 out of 36 counties in Oregon and 2 in Southwest Washington with technology infrastructure and network management support to connect individuals to health and social services.

Other Activities:

New REALD Data Collection Requirements

As required by <u>House Bill 4212 (2020)</u>, OHA rules now require health care providers to collect race, ethnicity, language, and disability (REALD) data for all COVID-19 encounters. After collection, providers must report this data to OHA with COVID-19 disease reporting. The requirement went into effect on October 1 for Phase 1 providers, with additional phases in 2021. Phase 1 providers include:

- Hospitals, except for licensed psychiatric hospitals;
- Health care providers within a health system; and
- · Health care providers working in a federally qualified health center

REALD Resources and Learning Series

To help providers understand these requirements and the importance of REALD data, OHA has launched <u>a website</u> with FAQs and other resources including a learning series. Additional learning sessions are planned. To learn more, <u>explore the slides and recordings</u> from the following REALD learning sessions:

- Implementing new REALD data collection for Phase 1 providers (providers in hospitals, health systems, FQHCs)

Federal Interoperability Final Rules Overview

The Oregon Health Authority has developed a <u>Federal Interoperability Final Rules webpage</u> that provides information and resources related to both the The Centers for Medicare and Medicaid Services (CMS) Interoperability and Patient Access Final Rule and The Office of the National Coordinator for Health Information Technology (ONC) 21st Century Cures Act (Cures Act) Final Rule. These rules focus on health IT certification, (which applies to health IT developers) and policy guidance on what does not constitute information blocking, (which applies to healthcare providers, health IT developers, and health information exchanges/networks).

In addition to these resources, the Oregon Association of Hospitals and Health Systems (OAHHS) and HIT Commons are co-sponsoring a provider-focused webinar on implications of the information blocking component of the ONC interoperability rule. This webinar will feature national experts from Davis Wright Tremaine LLP and PointB Consulting.

- The EDIE Steering Committee is currently assessing strategies to address the increase we're seeing in behavioral health visits over the last year, including evaluating a proposal to enable fatal/non-fatal overdose notifications within the Collective Platform

 Sixty-one Skilled Nursing Facilities are now sending census data to the Collective Platform.

PDMP Quarterly Dashboard (Q2 2019-Q2 2020)

- 79.5% of top 2,000 prescribers queried PDMP in Q2
- 138.2% increase in number of physicians and PAs using integrated access to PDMP since Q2 of 2019
- The number of prescriptions for opioid and benzodiazepine medications continues to decrease relative to the same quarter last year:

Opiates	% change – 2Q 2019*	% change – 2Q 2020*
Hydrocodone	-8.7%	-14.6%
Oxycodone	-5.8%	-10.6%
Tramadol	-2.5%	-6.9%
Benzodiazepines	% change – 2Q 2019*	% change – 2Q 2020*
Lorazepam	-5.6%	-3.4%
Alprazolam	-4.4%	-7.1%
Clonazepam	-4.2%	-2.9%
